## DIRECTIONS

**PLEASE NOTE:** We recommend that you make note of the parking deck number, elevator, and the row where you park. Avoid the hourly and reserved spaces.

### **From I-285 Westbound/"Outerloop" (from I-85 South/I-20 West/Augusta) \*See note below:**

Take Exit 28, Peachtree Dunwoody Rd. and turn right. (Exit 28 is the exit just before GA-400) Turn left at the 1<sup>st</sup> light, Concourse Pkwy., "General Concourse Entrance." Continue to the end of Concourse Parkway and turn right into the Tower Five and Six Entrance. Parking deck is immediately on the left. After parking, follow the signs to Tower Six, commonly know as the "King Building" and proceed to the 19<sup>th</sup> floor, Suite 1950.

### **From I-285 Eastbound/"Innerloop" from I-75 South/I-20 East/Birmingham) \*See note below:**

Take Exit 26, Glenridge Dr., and turn left. Turn right at Hammond Dr. and at the 2<sup>nd</sup> light, turn right into the "Hammond Drive Concourse Entrance". Turn left immediately into the Tower Five and Six Entrance. Parking deck is immediately on the left. After parking, follow the signs to Tower Six, commonly know as the "King Building" and proceed to the 19<sup>th</sup> floor, Suite 1950.

### **From GA-400 Southbound:**

Take Exit 5 (toward Sandy Springs), Abernathy Rd., and exit to the right. At the 1<sup>st</sup> light, turn left onto Barfield Rd / Glenlake Pkwy. At the end of Barfield Rd., turn left onto Hammond Dr. and make an immediate right at the 1st light, into the "Hammond Drive, Concourse Entrance." Turn left immediately into the Tower Five and Six Entrance. Parking deck is immediately on the left. After parking, follow the signs to Tower Six, commonly know as the "King Building" and proceed to the 19<sup>th</sup> floor, Suite 1950.

### **From GA-400 Northbound/ Downtown Atlanta/Airport:**

Take I-85 N to GA-400 N (Exit 87). Proceed on GA-400 to the Glenridge Connector (Exit 4A/ I-285). Veer right at the fork towards Johnson Ferry Rd. Turn left at the end of the ramp onto Glenridge Connector, which becomes Glenridge Dr. and turn right onto Hammond Dr. At the 2<sup>nd</sup> light, turn right into the "Hammond Drive, Concourse Entrance". Turn left immediately into the Tower Five and Six Entrance. Parking deck is immediately on the left. After parking follow the signs to Tower Six, commonly know as the "King Building" and proceed to the 19<sup>th</sup> floor, Suite 1950.

**\*Note:** I-285 is a circular by-pass around Atlanta so your direction of travel will continue to change. Miles Mediation is at the top (North) part of the loop. The terms "Westbound" and "Eastbound" refer to the direction you are heading at the time you exit off of I-285.
